## Action/implementation plan (2022-26)

October 2022 - The initial 5-year action plan (2017-21) is now complete.

This new 5-year Action Plan (2022-2026) was endorsed by SLT on 5 October 2022 to cover the 2022-2026 period of the Waste and Resource Recovery Strategy.
