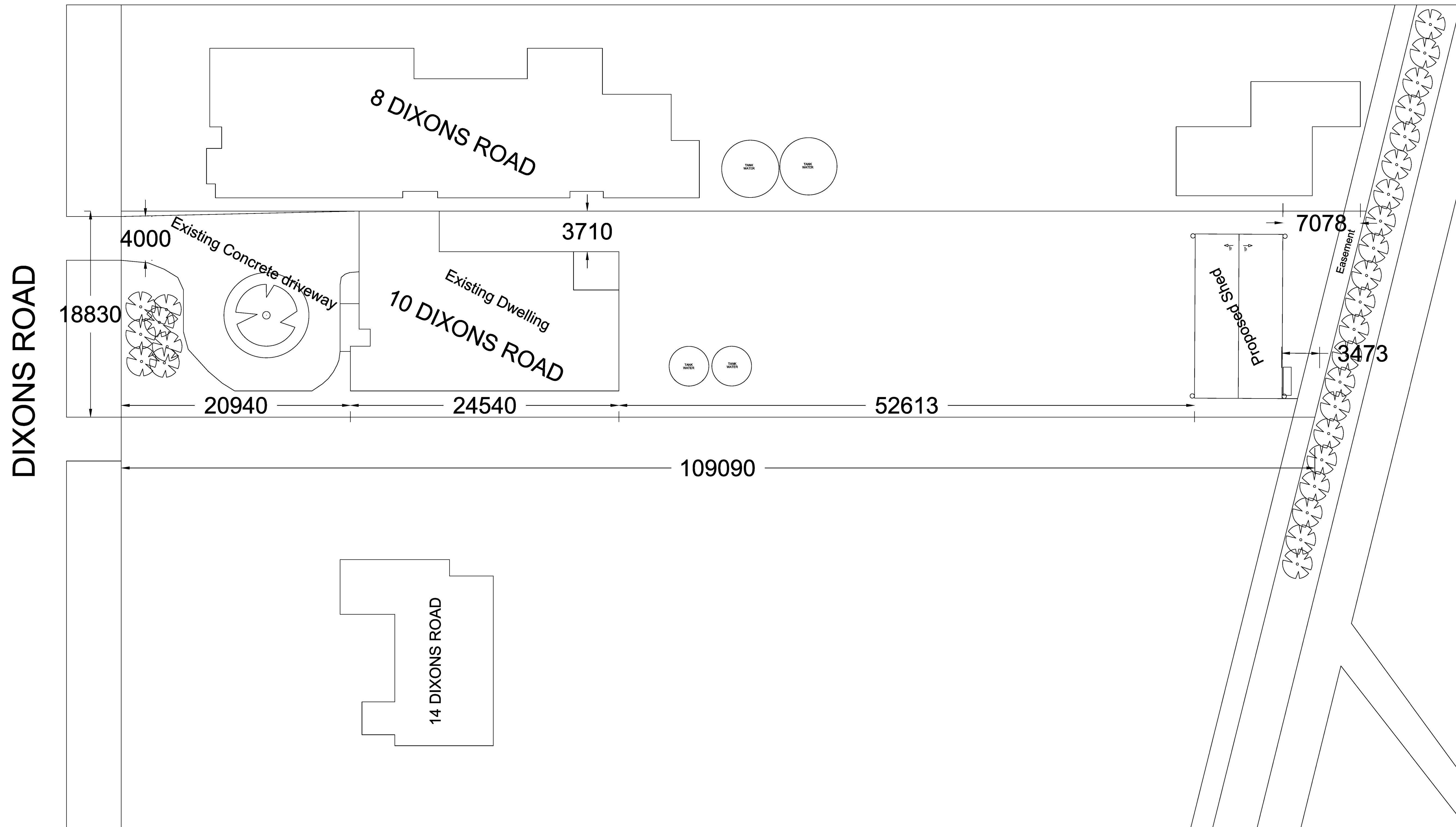
# 10 DIXONS ROAD CARDINIA VIC NEW PROPOSED SHED



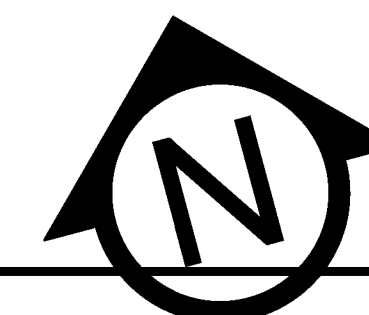
