## **Executive Summary**

Building a stronger economy: Cardinia Shire Council Economic Development Strategy 2023 - 2027, articulates Council's actions and commitment to grow, develop and support local businesses and the economy. The strategy's three primary pillars of partnership, regionalism and experiencing Cardinia and fostering the new economy are the cornerstones of this strategy which was developed in collaboration with business leaders and the local community.

## Background

Cardinia Shire Council was previously in a formal partnership with the City of Casey and had a joint Economic Development Strategy that delivered networking and awards events together. Casey experienced some planning issues that came to light in late 2019 and administrators were appointed in mid-2020. These circumstances together with the covid pandemic led Council to review our partnership. The covid pandemic also highlighted some significant differences regarding priority areas for each local government area. This included Cardinia's commitment and focus on supporting and growing our tourism and visitor economy. Ultimately council determined to end our formal partnership regarding economic development but agreed to work together on regional priorities and major projects and advocacy campaigns that benefited each council. These include Thompson's Rd, the south-east airport and several other joint initiatives supporting businesses through the pandemic.

Cardinia Shire Council is committed to building a sustainable shire for present and future generations to enjoy. We recognise that we have some significant challenges ahead; tackling climate change will continue to be one of the greatest challenges of our time, while the global COVID-19 pandemic has rapidly changed how we live, work, and connect.

Cardinia Shire aims to be a place in which our community and visitors thrive and prosper, with a local economy that fosters innovation and supports local jobs. Council aspires to be a leading local authority that leverages the strength of the region in advocacy, regional planning and investment whilst supporting and creating the opportunity for local jobs and business.

## **Policy Implications**

The Economic Development Strategy 2023 - 2027 aligns with Council's Liveability Plan, 2017 - 2029 and aims to meet goals under the employment outcomes: Cardinia Shire residents are skilled to access local jobs in a resilient, innovative, and thriving local economy. Workplaces are inclusive and promote the health, wellbeing, and safety of workers.



Our strategy also addresses the strategic indicator: Increase participation in local employment.

## **Climate Emergency Consideration**

The following activities are included in the Economic Development Strategy 2023–2027 to address the climate emergency concerns:

Increasing business adaptability - Providing a variety of business adaptability training programmes with collaborators like the Southeast Council's Climate Change Alliance

Assessments of the business sector's vulnerability to climate change and the promotion of sustainability initiatives among those businesses to maximise efficiency and the environment. Initiatives and supporting projects related to the circular economy are among them including significant uptake of climate adaptation projects by businesses.

Regional agriculture and food production strategy: Developing an integrated food strategy that produces primary goods locally and secondary goods with added value for the region, reducing food miles and protecting farmland.



## **Consultation/Communication**

Established in late 2020, the Pandemic Business Recovery Committee initially focused on Covid pandemic assistance initiatives, the allocation of state government funding to support outdoor dining activation, and the preparation of the next Cardinia Shire Economic Development Policy.

Through 2021–2022, there was ongoing communication with the recovery committee, business associations, Cardinia Shire organisations, internal business units, SLT, Eastern Dandenong Ranges Group (EDRA), and West Gippsland Progress Association (WGPA).

In April 2022, a draft of the plan was be made available on the Creating Cardinia site. Nine individuals, as well as EDRA and WGPA representatives, provided feedback.

Changes were made to the second iteration of the strategy after taking into account internal and external feedback, including the addition of further background information, a stronger connection to the Council Plan, and a focus on major priority areas such as local job creation and environmentally sustainable initiatives.

Further engagement occurred with our CALD and Access & Inclusion teams and then sent to the respective Advisory Committees.

## **Financial and Resource Implications**

The only project not currently budgeted is the development of a 'Regional Food Production Strategy' - 2027 action and milestone identifies the need to secure funding, including exploring external funding opportunities.

All other actions and initiatives can be delivered within current budgets.

#### Conclusion

The Cardinia Shire Economic Development Strategy has been created in collaboration with our business leaders and the broader community after extensive consultation and considering the effects of the COVID epidemic between 2020–2022. The strategy has a clear emphasis on local job creation, energising our state-significant industrial precincts, supporting and implementing program initiatives for climate adaptation, and increasing resilience and connections to the Cardinia Shire business community through the growth and strengthening of our local economy.

## **Cardinia Shire – An economic snapshot**

Cardinia Shire Council is looking at new possibilities for, and in conjunction with, its businesses and communities regarding a new direction and vision for its economic sustainability.

Driven by new infrastructure investment, Council's ambition for growth, and the COVID-19 pandemic, Cardinia Shire can build on its strengths while appealing to new talent and investment. With Cardinia's population expected to almost double by 2041, now is the time to invest in sound policy and programs, to deliver a strong local economy and a place where people are proud to live and work.

There is already a great deal on offer in Cardinia Shire:

- ✓ It offers affordable peri-urban living within metropolitan Melbourne with good connectivity via major arterial roads and metropolitan and regional train services.
- It has a strong agricultural sector, a developing industrial manufacturing sector, and large areas of underdeveloped land and connections to regional Victoria to support growing industry development and trends.

As a Council, Cardinia Shire is a growing organisation looking to transform the way we operate working on innovative and creative ways to achieve a collective vision for the shire and a different place for the future. We can offer strong leadership and partnerships, leveraging relationships with the state government, Southern Metropolitan Partnerships and the Greater South East Melbourne group of Councils (GSEM).

With numerous existing planning policies and structure plans supporting and encouraging growth related to employment and residential development as described in the <u>South East Growth Corridor</u> <u>Plan</u> and various Precinct Structure Plans, Cardinia Shire is 'investment ready' and cultivates market confidence. This will be essential to the shire's ability to attract more inbound and foreign direct investment.

The strategy is founded on creating new jobs and developing economically vibrant neighbourhoods. However, focusing on Pakenham and Officer and their connection to other neighbourhood activity

centres will be essential if the shire is to make use of its competitive advantages and forge a new shire identity over the medium to long term.

Urban sprawl, economic leakage, lower quality jobs, and radial trips to the CBD have been problems for Cardinia Shire. The present COVID-19 pandemic offers a 'window of opportunity' to reconsider policy options and projects, considering what could be more advantageous and achievable in a different setting. <sup>1</sup>



## **Projected employment and population**

To keep up with the region's anticipated population growth of 2.92% pa and lower overall unemployment levels, Cardinia Shire needs to provide opportunities for local businesses to fill vacancies and the ability to create new employment.

#### **Cardinia Shire population**

The population of Cardinia Shire is anticipated to rise by 102,629 people (105.14% growth) from 2016 and 2041, with an average yearly change of 2.92%. Currently, an estimated 131,834 people live in Cardinia Shire in  $2022.^2$ 



## Local employment

There were 33,219 jobs located in Cardinia Shire in the year ending June 2021.<sup>3</sup>

The jobs-to-residents ratio for Cardinia Shire in 2020/21 was 0.53, meaning that there were fewer jobs than resident workers. Agriculture, forestry and fishing had the highest ratio (0.97), while the lowest ratio was found in electricity, gas, water and waste services (0.22).<sup>4</sup>


27,776 or 61.9% of Cardinia Shire's resident workers travel outside of the area to work.5

#### **Future employment opportunities**

Cardinia Shire Council has a range of Precinct Structure Plans (PSPs) and employment corridors that will be developed in the next 20 years. It is anticipated that this will provide an additional 142,800 jobs for residents and the surrounding regions.

This region is identified as a State Significate Industrial Precinct (SSIP). The Officer–Pakenham SSIP encompasses the Officer South Employment, Cardinia Road, Pakenham West, and Pakenham South PSPs.

As the region matures, these locations will play a fundamental role in unlocking long-term employment opportunities. They will enable neighbouring townships to further evolve and mature to offer a diversity of job opportunities.




Figure 1 - SWOT findings diagram

## **COVID-19** pandemic and economic recovery
