Stephanie Davies submitted questions which were ruled out in accordance with clause 3.51.2 of the *Governance Rules*.

Mark Teague submitted 4 questions, these will be read and answered by General Manager Community and Planning Services.

In accordance with the *Privacy and Data Protection Act 2014*, personal information has been redacted from questions and not read aloud.

Question 1

Can Cardinia Shire Council please provide proof of this alleged resident complaint against the basketball hoop in front of [address]?

Response

Thank you for the question and I note that the information has been forwarded to yourself earlier today.

Question 2

After [an Officer] assessed the basketball hoop at [address], was there an official assessment completed? If so, can Cardinia Shire Council please provide this report?

Response

Council does not permit the permanent storage of personal items on public land, and therefore a full assessment report was not required.

Ouestion 3

Can the council explain why they feel it more important to remove a safe, well-loved and used piece of sporting equipment, for my son and other kids to use that has been in this location for over 8 years, and not focus on far more pressing matters in the local community?

Response

Council acknowledges that there are many pressing matters within the community and works diligently to address a wide range of issues. However, we also have a duty to respond to all matters brought to our attention, including those involving the use of public land and community safety. To meet Local Law requirements and public safety obligations, the basketball hoop needs to be relocated onto private property.

Question 4

What is the council prepared to do in the spirit of fairness and common sense, to make an allowance to keep the basketball hoop in its original location?

Response

Council must apply Local Laws consistently across the municipality to ensure safety, fairness and uphold community standards. Once a breach is identified, we are required to respond, regardless of how long the item has been in place.



Kurt Petersen submitted 1 question, and was not present at the Meeting the question was not read aloud.

Re: Pakenham Revitalisation Project

Ouestion 1

Has council considered advocating to DTP for Princes Hwy access upgrades in the name of safety and accessibility to the area (be it by new traffic signal installation or otherwise)? Has council considered difficultly in mobility being a roadblock to improving and increasing use of the main street area?

Response

Access will be further improved with the completion of stage 3 of the Pakenham Roads Upgrade project delivered by the State Government in mid-2026. This project includes the duplication of Racecourse Road and Healesville Koo Wee Rup Road from Henry Street to Princes Freeway and the construction of new traffic signals at the intersection with Bald Hill Road.

In addition, Council successfully applied for funding from the Victorian Government's Growth Areas Infrastructure Contribution fund for the duplication of McGregor Road between Duncan Drive and Heritage Boulevard and the construction of new traffic signals at Henty Street and Rogers Street. These works are expected to commence in 2025.

Trevor James submitted 4 questions, these will be read and answered by General Manager Infrastructure and Environment.

Re: Heritage Springs Estate lighting

Question 1

At the September 2025 meeting Council advised it has undertaken (A process review) in relation to the works and public lighting replacement; what was that process and has a result been achieved and if not when can that result be expected?

Response

Council has since this time engaged and worked with AusNet Services, undertaken community information sessions to discuss the replacement project.

A process review has been completed with some key outcomes including contractor documentation updates and officer education.

Council has worked with AusNet to have retrofit LED globes approved by the end of April 2026.

Question 2

In regards to the removal of the much loved Heritage Springs street lights and subsequent crushing/recycling of the lights, Council advises that Ausnet are investigating a retrofit led globe; what progress is being made?

Response

AusNet are involved in the electricity distribution price review (EDPR) process, which is led by the Australian Energy Regulator. Council expects that AusNet will advise the outcome of this review by the end of April 2026.



Ouestion 3

Why is it that the Heritage Springs residents group is receiving information from Ausnet which is entirely different to Council's advice?

Response

Council is not aware of the information being provided by AusNet regarding Heritage Springs lighting which differ to that provided by Council. We welcome information from the community on this matter.

Bill Ronald submitted 3 questions, these will be read and answered by General Manager Infrastructure and Environment.

Re: Heritage Springs Estate lighting

Ouestion 1

4th June 2024, Ausnet contactors removing Heritage Springs street lights was reported to the Mayor Jack Kowarzik, what action did the Mayor take, then and now 28 months later?

Response

Following this report, Notice of Motion 1096 was passed at the Council meeting on 17 June 2024. This notice of motion placed the removal of heritage style street light fittings in Heritage Springs on hold.

Council has since this time engaged and worked with AusNet Services, undertaken a community information session to discuss the replacement project and seek solutions.

Ouestion 2

At the Council meeting 17th June 2024 notice of motion 1096 was carried unanimously, when exactly (date required) did the Cardinia Council advise Ausnet of this Council resolution?

Response

Council passed a Notice of Motion 1096 related to halting replacement works coordinated by Council with AusNet approval. AusNet was contacted following this decision the following day. Council has continued to liaison with AusNet on this issue.

Question 3

In August 2025 Ausnet installed new street lights at the Heritage Livingstone Blvd, there was no requirement under AS1158 to remove adjacent heritage street lights which reduced the safety of the location, why did Ausnet remove the original lights?

Response

The intersection of Livingstone Boulevard and Heritage Boulevard was identified as a 'Blackspot' under Federal Government program as a high-risk area. The area required safety upgrades including lighting.

Henk Heeremans submitted 4 questions, these will be read and answered by General Manager Infrastructure and Environment.

Re: Heritage Springs Estate lighting

Question 1

Can Council provide documentation evidence that Ausnet is actively seeking a retrofit globe for the Heritage Springs street lamps?

Response

The Australian Energy Regulators publicly available "Draft decision AusNet electricity distribution determination 1 July 2026 – 30 June 2031" confirms the use of these globes is being sought by AusNet.



Question 2

Is Cardinia Council fully aware that Melbourne Aluminium and Iron Lace Work Company have available to councils and Estate Developers Australia wide, a range of Heritage Springs period Victorian style street lamps, complete with LED globes. All approved of course for sale in Australia?

Response

Council is required to utilise AusNet approved lighting hardware when replacing or installing lights on the AusNet street light network.

We are not aware that these lights have been approved by AusNet Services.

Question 3

Will Cardinia Council make themselves fully aware of the true facts on lamps and globes well in advance of the lead up to the April 2026 Council report?

Response

Council will consider the information available via AusNet as the network authority.

Ouestion 4

Why is it that Melbourne City Council and all the up-market surrounding suburbs have retained all their Heritage street lamps?

Response

Streetlights in the City of Melbourne are not all owned and managed by the distribution network service provider, therefore not governed by the same restrictions as the streetlights in Cardinia Shire.

The Mayor called a member of the gallery to order. The meeting was adjourned under clause 3.47 of the *Governance Rules* at 7.14pm for 3 minutes and resumed at 7.17pm.
