EXECUTIVE SUMMARY

At the closing date for the lodgement of submissions on the proposed sale of lot 3 at 335 McGregor Road over 4,000 submissions were received.

Details of the submissions received are included in the table attached.

BACKGROUND

At a Special Council Meeting held on Monday 28 May 2018, Council resolved, amongst other matters, to give public notice of the prosed sale of Lot 3 at 335 McGregor Road pursuant to sections 189 and 223 of the Local Government Act 1989, and in the event of submissions being received, a Special Council meeting be held on Monday 9 July commencing at 7pm to hear the submissions and the proposed sale of land be further considered by the Council at a further Special Meeting to be held at 7pm on Monday 23 July 2018.

The public notice advising of the proposal sale of the land appeared in the Pakenham Gazette newspaper on 30 May 2018, at the closing date of 5pm Thursday 28 June a total of over 4,000 submissions were received.

The purpose of tonight's meeting is to give an opportunity for any persons that have lodged a submission and requested to be heard to have that opportunity.
